Since the launch of the national trial on the 3rd April 2018 there have been 829 cases registered under the First-tier Tribunal's extended powers.

Please note: The 829 cases identified above were registered between the 3rd April 2018 and 14th May 2019. 108 decisions have been issued. Updates on the number of cases registered under the national trial will be provided on an ongoing basis in the national trial newsletter.

Summary of anonymised national trial decisions

The first summary of anonymised national trial decisions issued by the First-tier Tribunal Special Educational Needs and Disability, can be found here. The summary covers the period of September – December 2018.

The aim is to issue summaries on a quarterly basis for the remaining duration of the national trial; the summaries include:

National trial local area expenses guidance

Following feedback from Local Authority areas, summary guidance has now been created to support local areas with the expense claim process.

The guidance intends to provide direction to Local authorities outlining the process of reimbursing reasonable costs – up to the value of £4,000 per case – of attending a SEND Tribunal trial.
