COVID 19: SEND Disagreement Resolution

Latest information, advice and guidance from government departments

The Special Educational Needs and Disability (Coronavirus) (Amendment) Regulations 2020

The Secretary of State made amendments to the Children and families Act 2014 which came into effect on 1 May 2020. The amendments modify the duty on local authorities to secure special education provision and on health commissioning bodies to arrange health provision in accordance with EHC plans so that they can discharge by using their 'reasonable endeavours'.

- The announcement was made in a joint ministerial letter from Minister Ford, Parliamentary-Under Secretary of State for Children and Families, and Minister Whately, Minister of State for Care, to children and young people with SEND and their parents and carers. (Can be found at the top of the toolkit page under section A)
- A notice to modify section 42 of the Children and Families Act 2014 (lasting for one month, potentially renewable) will mean that local authorities and health commissioning bodies can discharge their duty to secure the provision set out in an EHC plan by using their 'reasonable endeavours'.
- The Special Educational Needs and Disability (Coronavirus) (Amendment) Regulations 2020 will temporarily amend four sets of Regulations that specify timescales for various processes relating to EHC needs assessments and plans. These changes will expire on 25 September 2020.

With regards to disagreement resolution changes specifically, the Amendment Regulations temporarily modify current timescales for:

- Actions that local authorities and health commissioning bodies must take where the Tribunal makes
 non-binding recommendations in respect of certain types of health and social care matters within an
 EHC plan.
- Actions that local authorities, parent carers and/or young people must take in relation to mediation.
- Actions required to register a SEND Tribunal appeal.

Frequently asked questions: disagreement resolution and coronavirus

Are SEND Tribunal hearings taking place during the Coronavirus lock down?

HM Courts and Tribunal Service has confirmed that its service will continue during the outbreak and that the tribunal is making efforts to conclude as many appeals as possible, particularly phase transfer reviews. HMCTS Priorities during the coronavirus outbreak.

Can I attend a SEND Tribunal hearing remotely?

Yes. You can attend a Tribunal by audio and/or video conference and HMCTS have developed specific <u>guidance</u> on how to join telephone and video hearings during coronavirus outbreak.

Are national trial SEND Tribunals continuing?

The national trial, which extends the power of the First-tier Tribunal (SEND), is continuing, until 31 August 2020. The trial provides that as part of a special educational appeal, the Tribunal will be able to make non-binding recommendations on the health and social care aspects of EHC plans. These recommendations need to be considered in the usual way by the responsible health and social care bodies and, where agreed, included in the final EHC plan. The modified S42 duty will then apply.

The Amendment Regulations will temporarily modify current timescales for actions that local authorities and health commissioning bodies must take where the tribunal makes non-binding recommendations in respect of certain types of health and social care matters within an EHC plan.

Are mediation services taking place during lock down?

Mediation services are still available during coronavirus using audio and/or video conferencing. Please speak to your mediation service provider to find out what processes they have put in place.

Are there changes to the timeframes in relation to mediation?

Yes. The time frames for considering mediation, commissioning mediation and the issuing of mediation certificates are also subject to the same amendment.

How can a parent carer or young person make a complaint during coronavirus?

The complaints mechanisms described in Chapter 11 of the SEND Code of Practice are unchanged, although the Local Government and Social Care Ombudsman has temporarily suspended all casework activity. In the first instance, families will often be able to use the local authority's or health commissioning body's complaints procedures. Local authorities and health commissioning bodies will need to ensure that these procedures remain effective for the current context. SENDIASS will continue to have a key role to play in supporting families in finding the best way forward.
